- Welcome** Hello and welcome to our CPE Trial in Escondido, CA.
- Location** [Hidden Valley Obedience Club \(HVOC\)](#), 3396 East Valley Parkway, Escondido, CA 92027
- Directions**
- From CA-78 East:** CA-78 to I-15 North, exit El Norte Pkwy. Turn right on El Norte Pkwy continuing to East Valley Pkwy. Turn left on East Valley Pkwy. Go past Eureka Springs and turn left at the traffic light at Beven Drive. Parking for training/trial will be in open field on your right.
- From I-15 Southbound:** Exit El Norte Parkway. Turn left (East) onto El Norte Parkway continuing to East Valley Parkway. Turn left on East Valley Parkway. Go past Eureka Springs residential area and turn left at traffic light at Beven Drive. Parking for training/trial will be in open field on your right.
- From I-15 Northbound:** Go north for about 6 miles on Via Rancho which becomes Bear Valley Parkway continuing until it ends at East Valley Parkway. Turn right onto East Valley Parkway. Go past Washington Ave/El Norte Pkwy and Eureka Springs residential area and turn left at traffic light at Beven Drive. Parking for training/trial will be in open field on your right.
