- * An evaluation is required before joining a class.
- * Reactive dogs need special training before joining class.

- * Dogs must remain on leash unless inside the ring, practice area.

- * Refunds or credit issued if class is canceled due to rain or other issues.
- * Please confirm class space is available before sending money.

DISCRIPTION OF CLASSES

Intermediate Agility Class – Experience required. Dogs must have more than a basic understanding of the agility obstacles. Focus is on enhanced obstacle performance, 12 weave poles, Advanced level drills and sequences. Distance and obstacle independence. Competition level training.

Beginning Agility Class – No experience required. Introduction to agility. Individual obstacle performance, including ramps, tunnels, jumps, barrels, and hoops. Basic obstacle sequences and drills. Skill levels vary between dogs in class.

- Beginner I – Just starting. Must get along with other dogs. On leash training.
- Beginner II – Performs all equipment and simple sequences. Off leash.
- Beginner III – Performs all equipment, weave poles and sequences. Off leash.

Evaluation – An evaluation is required before joining class.

DIRECTIONS

From I-805 South - Exit and turn right on La Jolla Village Dr, heading west. Turn left on Towne Centre Dr. Turn left on Nobel Dr. Turn left on Shoreline Dr. Turn right on Toscana Dr. Turn right into the parking lot by the athletic fields and then left to our agility area.

From I-805 North – Exit and turn left on Nobel Dr, heading west. Turn right on Shoreline Dr. Turn right on Toscana Dr. Turn right into the parking lot by the athletic fields and then left to our agility area.

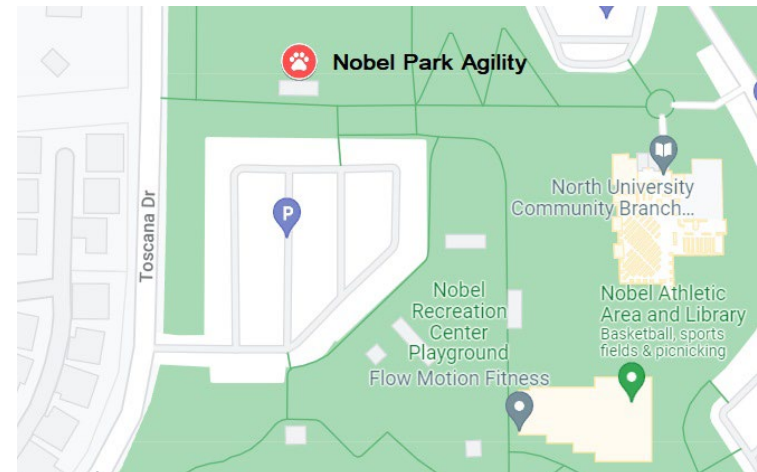
