AGILITY EVENTS / COVID-19

Amid CV19 circumstances, Performance Dog Training (PDT) will strive to keep you informed. As we navigate forward, be aware that our events require continued approval from the Host Organization, as well as Federal, State, and City governments and may change at any moment.

It has become necessary to make changes to the way we interact during this event as follows:

1. **CV19 MANDATES** – We follow the guidelines of the Property Owner, City and the Host Organization.
2. **CROWD CONTROL** – We have limited the number of entries and spectators.
3. **ENTRY FEES** – Entry fees are based on a daily rate per dog.
4. **REFUNDS / CREDITS** – If you need to cancel for any reason then you get a full refund or credit.
5. **STAY HOME** – If you are feeling sick or are considered “vulnerable”, please stay home.
6. **PPE / HYGENE / DISTANCING** – A mask is required. Maintain social distance. Soap and water are available.
7. **BRING YOUR LUNCH** – Bring your own food and drinks for the day.
8. **SCORES / RIBBONS / AWARDS** – Scores will be posted and we will hand out ribbons twice per day.
9. **DELAYS** – It takes a little more time to run the trial, so please be patient and ready to run when it’s your turn.
